Edward Balcerzan, professor at the Adam Mickiewicz University in Poznań, head of the Theory and History of the 20th Century Literature Division of the Department of Polish Philology. Author of several books, among them *Przez znaki. Granice autonomii sztuki poetyckiej* (1972), *Kręgi wtajemniczenia. Czytelnik, badacz, tłumacz, pisarz* (1982), *Poezja polska w latach 1939–1965, cz. I: Strategie liryczne* (1982), *cz. II: Ideologie artystyczne* (1988), *Smiech pokoleń – płacz pokoleń* (1997), *Literatura z literatury (strategie tłumaczy)* (1998).

Anna Łebkowska, professor at the Jagiellonian University in Krakow, works in the Division of the Anthropology of Literature and Cultural Studies in the Department of Polish Studies. Author of following books *Fikcja jako możliwość. Z przemian prozy XX wieku* (1991, 1998) i *Miedzy teoriami a fikcją literacką* (2001), as well as numerous articles devoted to the questions of gender theory, narratology, rhetoric strategies, anthropological study of literature as well as the study of contemporary fiction. She is currently working on a book on empathy as an anthropological category of literature.

Ryszard Nycz, professor, head of the Division of the Anthropology of Literature and Cultural Studies in the Department of Polish Studies at the Jagiellonian University in Krakow. Also works in the Institute of Literary Research of Polish Academy of Sciences. Editor in Chief of an academic journal, "Teksty Drugie" as well as the editor of two leading academic publishing series: "Horyzonty nowoczesności" (Universitas) and "Nowa Humanistyka" (Publishing House of the Institute of Literary Research of Polish Academy of Sciences). Wojciech Burszta, professor and the head of the Division of Cultural Anthropology at the University of Social Sciences and the Humanities in Warsaw. Anthropologist, Cultural Studies scholar. His recently published work includes *Różnorodność i tożsamość. Antropologia jako kulturowa refleksyjność* (2004), editor of the volume *Strategie śmierci, formy umierania. Świadectwa literackie i kulturoznawcze* (2004).

Anna Burzyńska, professor at the Jagiellonian University, head of the Division of the Literary Theory in the Department of Polish Studies. Scholar and writer. Author of the broad discussion of the relations of the theory of Jacques Derrida and early French Poststructuralism (*Dekonstrukcja i interpretacja*, 2001), numerous works on most recent literary theory as well as novels (*Fabulant. Powiastka intertekstualna*, 1997) and theater plays. Author of two-volume work *Teorie literatury XX wieku* (with Michał Paweł Markowski) (2006) and *Anty-teoria literatury* (2007).

Michał Paweł Markowski, professor, the Hejna Chair in Polish Language and Literature at the University of Illinois in Chicago, head of the Joseph Conrad International Festival of Literature in Krakow. Author of numerous books devoted to the relationship between philosophy and literature, translator and publisher of the works of Roland Barthes (1999-2001). He has recently published a book on the work of Bruno Schulz *Powszechna rozwijałość: Schulz, egzystencja, literatura* (2012).

Dorota Wolska, adjunct in the Division of Literary Theory in the Institute of Cultural Studies of the University of Wrocław. Recently published: *Clifford Geertz – lokalna lektura* (co-eds with Marcin Brodzki) (2002), *Aksjotypiczne przestrzenie kultury* (co-eds with Renata Tańczuk) (2005).

Elżbieta Rybicka, PhD, works in the Division of the Anthropology of Literature and Cultural Studies in the Department of Polish Studies of the Jagiellonian University. Author of books *Formy labiryntu w prozie polskiej XX wieku* (2000), *Modernizowanie miasta. Zarys problematyki urbanistycznej w nowoczesnej literaturze polskiej* (2003).
